# **Acceptable Use Policy**

By using our services, you agree not to misuse or abuse them in any way. If we notice any activities that violate this Policy, we may take action, including removing content or limiting access to the services. Please use your best judgment to ensure that your use of the platform aligns with both the letter and the spirit of this Policy.

#### 1. Scope

This Policy applies to all websites, software, and services operated by Reluna, including the platform's cloud services and related features.

#### 2. Prohibited Activities

#### 2.1. Disruption of Services

#### **2.1.1.** You may not:
